The City of Bloomfield, the Defendant, appeals to the United States Court of Appeals for the Tenth Circuit from the Findings of Fact, entered in this case on June 5, 2014 [Dkt. 124], the Supplemental Findings of Fact, entered in this case on July 16, 2014 [Dkt. 131], and the Memorandum Opinion and Order of the United States District Court for the District of New Mexico, entered in this case on August 7, 2014 [Dkt. 132].
