**JOINT STIPULATION OF
DISMISSAL WITH PREJUDICE**

Plaintiffs Global Impact Ministries, Inc, Justin Reeder, Carl Ubinas, Jason Oesterreich, Isaiah Burner, Andre Gonzalez, Leroy Stokes, Jr, Richard Whittier, and Jon McAtee and Defendant Guilford County jointly stipulate to the dismissal of this action with prejudice. In support thereof, the parties state as follows:

1. Plaintiffs have reached a resolution in this case that resolves all claims against Defendant Guilford County.
2. Plaintiffs and Defendant Guilford County stipulate that all claims in this lawsuit against Guilford County should be dismissed with prejudice.

3. This is not a class action lawsuit, no receiver has been appointed, and no federal statute requiring a court order for dismissing a case governs this lawsuit.
4. Plaintiffs have not previously dismissed any federal or state lawsuit based on or including the same claims as those presented in this case.
5. Except as agreed to in their settlement agreement, each party is to bear its own costs, expenses, and attorneys' fees.
6. Plaintiffs and Defendant Guilford County ask this Court to consider the settlement agreement, attached as Exhibit 1, and dismiss the claims between them in accordance with its terms.
