COME NOW the Plaintiffs, Child Evangelism Fellowship of Pennsylvania, Inc. (“CEF”) and Dr. Steven D. Landman, by and through their counsel, and pursuant to Federal Rule of Civil Procedure 41(a)(1)(A)(i) file this voluntary dismissal stating the following:

1. On October 21, 2008, Plaintiffs filed a Verified Complaint challenging the school district’s policy and practices both facially and as-applied by the Defendants to prohibit Plaintiffs from accessing the District’s flyer forum opened up to nonprofit community organizations.
2. Plaintiffs alleged that the Defendants denial of access was premised solely on the religious content and viewpoint of Plaintiffs’ flyers and after-school meeting activities.
3. As a result of subsequent settlement discussions between the parties, the Defendants have agreed to treat Plaintiffs on an equal basis with all other community groups.
4. The Defendants also agreed to pay Plaintiffs’ attorneys’ fees under 42 U.S.C. § 1988.

5. Based on the above actions of the Defendants, Plaintiffs agree to dismiss their lawsuit against the Defendants, with prejudice.
