**ORDER ON MOTIONS TO DISMISS, TEMPORARY-INJUNCTION BRIEFING
AND HEARING SCHEDULE, AND RELATED MATTERS**

In accordance with the deadlines the Court set at a hearing held on May 8, 2024, and Plaintiffs having filed a Motion for a Temporary Injunction on May 31, 2024, the Court ORDERS as follows:

1. Defendants' responses to Plaintiffs' Motion for a Temporary Injunction are due on June 24, 2024.

2. Plaintiffs' reply in support of their Motion for a Temporary Injunction is due on July 8, 2024.

At a hearing held on June 5, 2024, the Court ruled and now ORDERS as follows:

3. Defendants' Motions to Dismiss Plaintiffs' First Amended and Supplemental Petition are GRANTED with respect to Plaintiffs' First Claim for Relief and DENIED with respect to Plaintiffs' Second, Third, and Fourth Claims for Relief.

4. Defendants' answer to the First Amended and Supplemental Petition (with respect to the Second, Third, and Fourth Claims for Relief) shall be filed by July 5, 2024.

5. Plaintiffs are granted leave to amend with respect to the First Claim for Relief, if they so desire, by June 24, 2024. If Plaintiffs file such an amendment, Defendants shall file a

response to the amendment within twenty days of the filing of the amendment; the response may be a supplemental answer with respect to the amended First Claim for Relief, or a new motion to dismiss it.

6. The Defendants' Motions to Dismiss having been denied with respect to Plaintiffs' Second, Third, and Fourth Claims, and the stay placed by the Order filed on May 29, 2024, of Plaintiffs' Notice of Deposition of Defendant St. Isidore of Seville Catholic Virtual School having accordingly expired, the parties are encouraged to cooperate with regard to deposition scheduling.

7. By July 1, 2024, at 5:00 pm, the parties shall exchange lists of witnesses and exhibits for the hearing on Plaintiffs' Motion for a Temporary Injunction.

8. A prehearing conference concerning Plaintiffs' Motion for a Temporary Injunction—where the Court may address any disputes the parties may have concerning witnesses or exhibits—shall occur via Microsoft Teams on July 15, 2024, at 9:00 am.

9. The hearing on Plaintiffs' Motion for a Temporary Injunction shall start on July 24, 2024, at 9:00 a.m., and shall continue through July 25, 2024, and July 26, 2024, if necessary.






